## RESOLUTION OF THE ETHICS AND DISCIPLINARY COMMITTEE

Case No.: EDC/2026/001

Matter: Mr. Femi Ayandibu Vs African Boxing Date: 26th  
March 2026

The Ethics and Disciplinary Committee, having sat over the matter of Mr. Femi Ayandibu versus African Boxing, and having carefully considered all facts, evidence, and submissions presented by the parties, hereby issues the following **RESOLUTION:**

**WHEREAS** the Committee finds Mr. Femi Ayandibu guilty of misconduct that warranted disciplinary action; and

**WHEREAS** the Committee notes that this is Mr. Femi Ayandibu's first offence; and **WHEREAS** the Committee has decided to temper justice with mercy in view of the foregoing; **IT IS HEREBY RESOLVED AS FOLLOWS:**

### 1. Public Apology

Mr. Femi Ayandibu shall write a formal apology letter addressed to:

- The President of African Boxing,
- The Vice President of African Boxing, and
- All relevant stakeholders in the African boxing community, an apology to the Nigeria Boxing Federation (NBF) for your actions that embarrassed the Nigeria and the Nigerian boxing family.

### 2. Publication of Apology

The apology letter shall be published and circulated by Mr. Femi Ayandibu on all boxing platforms, including (but not limited to) social media handles and other major boxing stakeholders within seven (7) days of the receipt of this Resolution.

### 3. Suspension

Mr. Femi Ayandibu is hereby suspended from all boxing activities (local, continental, and international) for a period of six (6) months with effect from the date of this Resolution.

### 4. Warning

Any repetition of similar misconduct by Mr. Femi Ayandibu or any other member shall attract far more stringent sanctions, as the arm of justice shall no longer be tempered with mercy.

This Resolution is final and binding and shall be communicated to all relevant boxing federations, commissions, and stakeholders for immediate compliance and enforcement.

Adopted and issued this 26th day of March 2026 by the Ethics and Disciplinary Committee.
